

# Gender Pay Gap Reporting 2022

## What is gender pay gap reporting?

From 2017 onwards, UK businesses employing 250 or more employees must publicly report details of their gender pay gap. There are six elements that must be reported:

- the mean gender pay gap
- the median gender pay gap
- the mean gender bonus gap
- the median gender bonus gap
- the proportion of men and women who received bonuses, and
- the proportion of men and women within each quartile pay band.

The gender pay gap shows the difference in the average earnings and bonuses of all male and female employees in an organisation.

The mean gender pay gap is the difference between the mean (average) hourly rate of pay of male relevant employees and that of female relevant employees. The median gender pay gap is the difference between the median hourly rate of pay of male relevant employees and that of female relevant employees. The median values are obtained by separately ranking all male and all female employees pay rates from lowest to highest then identifying the male and female who fall in the middle of these two rankings. The mean and median gender pay gaps are calculated as at a snapshot date of 5th April 2022. The mean and median gender bonus gaps report the difference between bonuses paid to men and women in the year to 5th April 2022. The gender gaps for pay and bonuses are expressed as a percentage of men's pay. A positive gender pay gap percentage shows that males are paid more than females, whereas a negative gender pay gap shows that females are paid more than males.

## Pay and Bonus Gap

The table above shows that at the snapshot date of 5<sup>th</sup> April 2022, the mean pay for female employees was 3.9% lower than that of male employees. However, the median pay for female employees was 15.8% higher than that of male employees. This difference is due to the profile of employee roles within the organisation. Of the 453 employees, 120 are nurses or physician associates (PA's), of which 93 are female. Similarly, 95 of the employees are drivers, of which 90 are male. Nurses and PA's command a higher rate of pay than drivers and the fact that the majority of nurses and PA's are female and the majority of drivers are male means that median rates of pay are higher for female employees than males. The organisation has recently increased the number of employed

GP's to 6, of these 5 are male. All 6 of these employees feature in the top 10 hourly paid for the entire organisation which has increased the mean rate of pay for males leading to a mean gender pay gap of 3.9%.

In the year to 5<sup>th</sup> April 2022, 93.2% of male employees on the April 2022 payroll received a bonus, compared to 87.7% of females. All employees on payroll as at 30 September each year are eligible for a bonus payment. Anyone joining the organisation after 30 September 2021 would not have been paid a bonus in the year to 5 April 2022. The mean bonus paid to female employees was 6.7% higher than that of males. The median bonus paid to female employees was 19.1% higher than that of male employees. Employee bonuses are a function of an employee's contracted hours and length of service and are not related to rates of pay. The organization aims to provide an equal bonus net of PAYE deductions therefore when including the additional PAYE contribution female bonuses are higher due to the higher hourly pay rate due to higher PAYE contribution rates.

## Pay Quartiles

Pay quartile data is compiled by ranking all employees from the lowest rate of pay to the highest. This list is then split into four equal sizes. Quartile 1 includes the 25% of employees with the lowest rate of pay, quartile 2 the next highest 25%, quartile 3 the next highest 25% and quartile 4 the highest 25%.

The table below shows the proportion of male and female employees within each pay quartile as at the snapshot date of 5<sup>th</sup> April 2022.

Overall 61% of the organisation's employees are female. Within quartiles 1 and 2 there is an approximate even split between males and females therefore a higher proportion of males compared to the organisational average. Quartile 3 and 4 contain an equal or higher proportion of females compared to the organisational level split. These quartiles primarily include the nurses, GPs and physician associates, who are predominantly female. In recent years the organization has employed an increasing number of GP's and physician associates who are predominantly male.
